# 1. What is this course about?

#### 1.1. Description

This one-semester introductory course provides a comprehensive foundation in the field of Economics. You will understand the fundamental principles governing economic systems and decision-making processes by exploring key concepts and theories. Strong emphasis will be placed on critical thinking and problem-solving, challenging you to apply economic principles to real-world scenarios. You will develop a holistic understanding of economics and its significance in individual decision-making, societal welfare, and global economic issues. The course is structured into three modules: Macroeconomics, Microeconomics, and International Economics, where each module addresses different United Nations' Sustainable Development Goals (SDGs).
