1. What is this course about?

1.1. Description

This course introduces you to computer modelling, focusing on the fundamental principles of engineering mechanics. The emphasis is on helping you develop a deep understanding of the laws and principles of mechanics by applying computer structural modelling. The course covers the analysis of both determinant and indeterminate structures using industry software for structural analysis. By mastering this course, you will acquire essential skills for structural analysis, modelling, and design of civil engineering structures.

1.3. Course Topics

Topics may include:

- Computational modelling fundamentals
- Application of loads, load factors, and load combinations using structural analysis software
- Linear and nonlinear analysis of structures
- Analysis of wind effects using computer modelling software
- Computer modelling of statically determinate and indeterminate beams, frames, and trusses
- Deflection analysis using computer modelling software
- Creating Influence lines using computer analysis for beams and trusses
- Structural modelling of 3-dimensional structures

300 Level (Graduate)
