1. What is this course about?

1.1. Description

This course provides you the second opportunity to apply a holistic integrated approach to counselling within an organisational counselling context. You will continue your integration and development of advanced counselling skills, theories and knowledge, applying them under supervision in an ethical and professional manner. You will engage in experiential learning, that is, first-hand experience about what it means to practice in the field of Counselling.

1.3. Course Topics

Industry placement: Students will complete 200 hours of placement within a host organisation. This is generally completed on a 2 days per week basis throughout the semester.

Students will additionally attend a 2-hour supervision group on campus each fortnight.
