1.1. Description

You will research, analyse and interpret the theories that inform what is known about learning and the forms of knowledge valued by such theories. You will evaluate the interplay of theory and practices that enable quality learning.

All - Assessment Task 3: Review of Literature and Quality Teaching Model

GOAL:	The goal of this task is to produce a literature review of what constitutes quality teaching and learning in 21st century schooling, along with the creation of a visual representation.					
PRODUCT:	Literature Review (or component)					
FORMAT:	There are two parts to this task. Part One: You will review relevant literature to address the broad question: What is quality teaching in the 21st century and how does it support student engagement in your discipline/specialisation area? You are required to discuss the implications of learning theories and educational research at your level of schooling. Give consideration to students' developmental needs and how quality teaching is related to managing behaviours through engagement. Critically analyse the roles of teachers and schools in the 21st century. Your review of literature and theory should be written in the appropriate academic style, utilising APA 7th ed. referencing conventions. Part Two: On a single A4 page, create a model of quality teaching that represents your findings from your literature review. This diagram, picture or graphic should be appropriately labelled with descriptive text and have a caption (title) so that it can be understood independently of the literature review. It must be in digital format to be uploaded to Canvas, along with your literature review. You should refer to your model throughout your literature review.
