### 1.1. Description

In this course students articulate why Steiner teachers call their teaching practice 'the art of education'. You will apply your understanding of anthroposophy and human development to reflect critically on how the art of education recognises and supports unfolding capacities in the human being and informs Steiner pedagogical practice.

### 10.1. Assessment: Academic Integrity

## 10.3. Assessment: Submission penalties

Late submission of assessment tasks may be penalised at the following maximum rate:

- 5% (of the assessment task's identified value) per day for the first two days from the date identified as the due date for the assessment task.

- 10% (of the assessment task's identified value) for the third day - 20% (of the assessment task's identified value) for the fourth day and subsequent days up to and including seven days from the date identified as the due date for the assessment task.

- A result of zero is awarded for an assessment task submitted after seven days from the date identified as the due date for the assessment task. Weekdays and weekends are included in the calculation of days late. To request an extension you must contact your course coordinator to negotiate an outcome.
