1. What is this course about?

1.1. Description

This course is designed to orientate you to the profession. You will develop specialised knowledge and application of teaching and learning through a 10 day professional experience (PEX) placement. You will critically analyse, reflect on and synthesise literature and broader perspectives related to learning theory, education policy, practice and effective teaching and learning over time. This course also provides you with the requisite knowledge of professional ethics and legislative requirements to be able to employ high levels of personal autonomy and accountability in your professional practice of the Australian Professional Standards for Teachers.

FORMAT:	<p>Part One: Placement You will engage in 10 days of Professional Experience (PEX). During this time, you will undertake observations and reflections of the teaching and learning cycle learning, teach mini-lessons, engage with the school community to explore professional practice (refer to your PEX Handbook) and conduct yourself in accordance to the UniSC SETA Code of Conduct. The Final Report for your PEX assesses your demonstration of the APST (1.1, 1.2, 1.3, 2.1, 2.2, 2.3, 2.6, 3.7, 6.1, 6.2, 6.3, 7.1, 7.2, 7.3, 7.4) and it will be completed by your Supervising Teacher/Site Coordinator at the end of your PEX.</p> <p>Part Two: Placement critical reflection This task enables you to critically reflect on your 10-day PEX. To achieve this, you will prepare a synthesis of your knowledge of professional standards, contextual considerations, effective teaching and learning and feedback from your PEX, to demonstrate your understanding of impacts on student learning. This part of the task will be presented at the post-PEX debrief tutorial.</p>

10.1. Assessment: Academic Integrity
