## 1. What is this course about?

### 1.1. Description

In this course you develop the knowledge and skills necessary to plan, implement, and evaluate midwifery care. You undertake clinical experience placements across the maternity care continuum (120 hours). You will be supported and supervised by experienced practitioners and critically self-appraise your practice. Your facilitator will evaluate your work at a developing student level against the NMBA Midwife Standards for Practice. In addition, you will work towards meeting the required midwifery practice experiences for the program and continue your Continuity of Care experiences (CONNECT).

### 1.3. Course Topics

- Safe administration of intravenous and epidural medication, in the maternity setting.
- Interventions during labour: Artificial Rupture of Membranes (ARM), induction of labour.
- Foetal monitoring – CTG interpretation.
- Management of women with gestational diabetes in labour.
- Management of women with hypertensive disorders in labour.
- Complications of birth: shoulder dystocia and cord prolapse.
- Management of postpartum haemorrhage (PPH) and blood transfusions.
- Caesarean section – post surgical care.
- Neonatal resuscitation
