This course equips General Practitioners, Registered Paramedics and Registered Nurses with the specialist skills, and knowledge of intravenous fluid management and antimicrobial stewardship for non-life—threatening urgent conditions in Urgent Care settings (acute injuries/minor illness).

Fluid management and antibiotics

- Fluid resuscitation Rehydration (gastritis gastroenteritis, migraine, morning sickness, hangover); Haemorrhage (Upper GIT e.g. oesophageal varices, peptic ulcer; Lower GIT e.g. rectal bleeding; Vaginal bleeding e.g. miscarriage, ectopic, post menopause)
- · Antibiotics therapy Cellulitis; Pyelonephritis
