## 1.1. Description

The management of patients within Urgent Care clinics involves an understanding of factors that affect safety and quality in healthcare. The specialist skills and knowledge of culturally safe practice is integral to the provision of safe clinical practice in Urgent Care. To prepare you for your professional role you will develop knowledge to provide culturally safe healthcare. You will critically appraise your clinical knowledge and practices and develop capabilities for cultural safety.
