#### 1. What is this course about?

#### 1.1. Description

In this course you will continue practical work on your research project under the direct guidance of your Honours Supervisor, with a focus on developing more advanced knowledge and skills. For students studying full time, the course provides an opportunity for advanced work on your project while concurrently preparing your dissertation and final presentation. For part-time students, the course provides an opportunity to implement the second stage of your research plan under the guidance of your Supervisor. Specific activities related to your project will be determined by your Supervisor.
