1. What is this course about?

1.1. Description

This course examines the role history and politics play in shaping security in the Northeast Asian region. It outlines the foundations of tensions between China, Japan, Taiwan, Vietnam, the Philippines, Malaysia, Indonesia and North and South Korea as they negotiate their changing economic and military status. Are security tensions inevitable? The Northeast Asian region offers us a useful case study in contemporary International Security. The course also considers some implications for Australian policy towards the region.

All - Assessment Task 2: Symposium and essay

GOAL:	The symposium event has been designed to create an authentic research experience emulating Political Science conference practice. It is a requirement of the course to attend to all sections of this symposium.
PRODUCT:	Essay
FORMAT:	1500 words - The symposium is an opportunity for you to discuss your essay's research and findings in an open forum with all your peers present at one time. Submit symposium essay to Canvas prior to the day of the symposium. Bring along to the symposium a copy of your essay for your own reference. The symposium will address some of the issues raised and discussed during the online learning materials, seminars and tutorials in previous weeks. The symposium essay will be written as a formal academic essay and will apply the Harvard style of referencing with a List of References (LOR) at the end. A contemporary issue or event that relates to the theories and practices covered during the course will be investigated and analysed. Important guidelines and discussion regarding the topic and how to approach it will be presented in the tutorial 2 weeks prior to the symposium. Research the symposium topic, write the symposium Paper, and present your observations during the symposium. Further discussion regarding the symposium topic will also occur during the tutorials.
