1. What is this course about?

1.1. Description

In this course you will be guided by a practising solicitor in a simulated work environment for 3 hours a week. During this time you will have the opportunity to observe and participate in the provision of legal assistance to real clients. In conjunction with a practising solicitor you will be involved in client interviews, conducting legal research, preparing legal advice and drafting correspondence. This course will develop your practical skills and your understanding of the daily life of a legal practitioner.

1.3. Course Topics

This course focuses on building your legal professional practice skills in a simulated work environment. You will learn:

- Interviewing Skills – *How do you identify legal issues in a courteous and professional way?*
- Legal Research Skills – *What information is required to be able to suitably give advice on the matter?*
- Drafting and Collaboration – *How do you professionally produce advice and communicate with clients and other involved parties?*

Due to the nature of this course that deals with real people and their legal problems, the legal issues and areas of interest can differ widely from trimester to trimester. In some instances, this information may contain mature content that requires professionalism and empathy.

6. How am I going to be assessed?

6.2. Details of early feedback on progress

Students will receive constant feedback from their supervisor during each session. In Week 1 or 2 students will begin assessment Task 1a which is a formative assessment task requiring them to self-assess their skills against an array of criteria. They do this by completing a Learning Contract. The students will then re-assess themselves against the same criteria in Weeks 7 and 12. This task will assist students to determine their own learning needs within the overall goals of the course, to structure and direct that learning, and to map their progress throughout the trimester.
