1. What is this course about?

1.1. Description

This professional experience placement introduces you to the clinical environment, applying foundational nursing skills, communication, and person-centred care. Under supervision, you will engage in direct care, observation, and reflection to build safe, ethical, and responsive practice. This 80-hour placement reinforces NMBA Registered Nurse Standards for Practice and aligns with national quality and safety standards, supporting your transition from theory to practice and preparing you for ongoing learning and future placements.
