1. What is this course about?

1.1. Description

This course establishes a foundation for nursing practice, integrating core skills with holistic assessment across the lifespan. You will engage with regulatory, ethical, and professional standards while developing communication and clinical abilities. Through practical classes and placements, you will build proficiency in therapeutic relationships, assessment, and essential interventions, aligned with NMBA and national quality and safety standards to ensure safe, person-centred care.

• Clinical Foundations

Clinical documentation; vital signs; hand hygiene; infection prevention and control principles.

. Fundamentals of Patient Care & Safety

Patient-centred activities of daily living; communication for safety, escalation of care, graded assertiveness, and ISBAR handover.

• Neurological & Neurovascular Assessment

Neurological physiology, assessment, and observations; neurovascular physiology and assessment.

• Cardiovascular Assessment

Cardiovascular physiology and assessment, including introduction to 12-lead electrocardiogram.

Respiratory Assessment

Respiratory physiology and assessment; introduction to simple oxygen delivery devices.

• Gastrointestinal & Abdominal Assessment

Gastrointestinal physiology; abdominal physiology and assessment.

• Genitourinary Assessment

Genitourinary physiology and assessment.

Integumentary & Musculoskeletal Assessment

Integumentary physiology and assessment; musculoskeletal physiology and assessment.

• Pain Assessment

Patient-centred pain assessment and management principles.

Safe Medication Practice

Medication calculations; concepts and principles for safe administration of non-parenteral medication.

10.1. Assessment: Academic Integrity
