1.1. Description

This work integrated learning course is essential for preparation for professional practice as a dietitian and is a component of the SC402 Bachelor of Dietetics honours project pathway. Under the supervision of an experienced research supervisor, you will demonstrate competencies in nutrition and dietetics research workplace setting. You must complete a minimum of 20 full-time equivalent days over a placement block. The location of the placement will be provided prior to commencement.

8.2. Specific requirements

You will be required to participate in 20 days of research activities that develop your skills in applied research. This placement will allow you to demonstrate the relevant National Competency Standards for Dietitians in Australia. You will be assigned a research supervisor who will supervise and coordinate these activities.

10. What administrative information is relevant to this course?

10.1. Assessment: Academic Integrity
