# 1. What is this course about?

#### 1.1. Description

This competency-based course is designed for you to develop and demonstrate core generic skills for occupational therapists, prosthetists or orthotists including group facilitation, splinting, communication skills, and interviewing techniques. A key component of this course is your development of safe manual handling procedures. You will also extend your skills in profession-specific activities (e.g., environmental modifications, splinting, outcome measures, wheelchair prescription).

This is a critically important skill and is covered in the first two week's learning materials and tutorials and you will receive feedback on your skills from your peers in weeks 2 and 3.

GOAL:	You will complete an oral viva and a SOAP note to demonstrate your knowledge and practice of safe procedures in infection control and all manual handling tasks. You will be also assessed on your knowledge and skills in all of the following; wheelchair prescription, splinting, environmental modification (occupational therapy students only), P&O outcome measures (prosthetics and orthotics students only), and prescription of mobility aids during the practice education sessions. This task directly develops your core professional competencies.

FORMAT:	Skills and professional competencies will be assessed in the practice education sessions from week 6 through to week 13. A second marker may be present, or video recording taken, to assist moderation.
