# 1.1. Description

How does society's understanding and construction of sex, gender and sexuality impact how you experience yourself? In this course, you will be critically examining a sociological understanding of gender and explore the connections between gender identity/expression, personal experience and social structures, and the changing social position of cisgender and transgender women and men in contemporary Australia. You are encouraged to examine issues related to gender such as stereotypes, media images of female and male bodies, health, sport and sexual identity and sexual politics.

All - Assessment Task 2: Presentation analysing the impact of gender experiences in contemporary Australia and facilitated discussion

GOAL:	This exercise requires you to use a gendered perspective to develop an advanced critical understanding of how gender affects men, women or non-binary people from a list of provided topics.					
PRODUCT:	Oral and Written Piece					
FORMAT:	In groups of 2 or 3, you will present a contemporary gender issue in Australia and hand in the transcript for written evaluation. Presentations will run from Week 6 to Week 12.  The specific details will be in your Task 2 folder in Canvas.					
	The presentation should take 10 minutes followed by a class discussion of around 10 minutes duration conducted by the presenters. Questions to stimulate discussion should be posed to the whole class by the presenters at the end of the presentation.  You are expected to consult at least six scholarly sources in researching for this presentation, which should be evident the referencing and reference list.

### 10.3. Assessment: Submission penalties
