### 1.1. Description

Professionals in many settings are required to work with Aboriginal and Torres Strait Islander peoples, and multicultural communities demonstrating professional practice standards, values, and ethical principles. Students will develop relevant knowledge to critique current ways of working with Aboriginal and Torres Strait Islander peoples and multicultural communities. Students will develop specific strategies and skills to engage and provide culturally responsive services.

### 10.2. Assessment: Additional Requirements

#### **Eligibility for Supplementary Assessment**

Your eligibility for supplementary assessment in a course is dependent of the following conditions applying:

### 10.3. Assessment: Submission penalties
